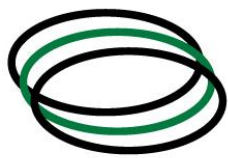

## **1.Introduction**

### **1.1 Type of Tender Procedure**

Kotronis Packaging (company) is conducting a tender procedure to receive proposals regarding the provision of Central Conveying System, in the frame of PRACCIS project. This project refers to a Central feeding system that will automatically convey the raw materials to the injection molding machines.

## **2. Description of PRACCIS Project and contract scope**

### **2.1 Project description**

PRACCIS project is a main part of the company's strategy for automatization into all stages of the production process.

As part of "PRACCIS" Project which is supported by Grant from Iceland, Liechtenstein, and Norway through the EEA Financial Mechanism 2014-2021 in the frame of the Programme "Business Innovation Greece", Kotronis Packaging will proceed with the purchase and installation of Central Conveying System.

The Central Conveying System will consist of the necessary pipping system which will connect the silos with the machines, the vacuum supply for the proper operation of the system, the distribution stations, the dosing and mixing units and a central control system which will monitor the material supply and assure that every desired connection of a material to a processing machine in the production process is made automatically and without any chance of cross contamination.

### **2.2 Contract scope**

Contract scope consists in the provision of implementation services and the purchase of the suitable equipment of automated Central feeding system.

Project implementation is divided into two modules:

- 1.** Automatization of the process.
- 2.** Real time Monitoring and Optimization of the process.

The technical specifications such as quantities can be requested and sent in writing via email to all potential bidders.
